<p><u>Technical Specifications for implantable and programmable Microinfusion pump & Microinfusion pump management system:</u></p> <ol style="list-style-type: none">1. This should consist of microinfusion pump and management system2. The implantable and programmable pump should comply with the following<ol style="list-style-type: none">1. It should be completely implantable in rats subcutaneously.2. It should be communicating through USB to Data Communication Device3. It should allow free movement to animals without any restrain (i.e. tethering) during drug infusion.4. It should have refillable reservoir which should be elastic and configured in such a geometry as to allow gentle palpation to confirm an approximate level of fluid in the reservoir.5. It should be able to replenish any medical fluid in the pump via percutaneous access to the pump refill septum.6. The Start Time, End Time, Flow-rate (1.0µl/hour to 30.0µl/hour), Constant and Variable infusion mode shall be programmable as per user requirements.7. The pumps should be programmable thus indispensable for applications where accurate flow infusion, recovery/washout periods, constant/variable dose or complex circadian infusion studies are necessary.8. The pump should be able to start administration instantly at the pre-programmed start time & date and continue to infuse for the pre-programmed flow-rate and duration.9. The battery life should be up to 6 months at a flow rate of 1.0µL/hr continuously10. The basic principle should be peristaltic movement of the reservoirs controlling the infusion.11. The accuracy range shall be +/-4% or better.12. The activation method should be IR communication based.13. The flow rate range should be 1.0µL/hr - 30.0µL/hr (Resolution : 0.1µL)

6. **Financial bid should be in INR for NIMHANS door delivery price** and total cost with detailed breakup of cost towards Item wise price, taxes, any surcharges (such as transportation, installation, customs duty, etc.), warranty/expiry period, delivery period, contact person details (such as Mobile No., E-mail, local supplier address) should be clearly mentioned.
7. **Quotation must be submitted along with relevant documents counter signed along with seal by the bidder (such as Authorization certificates, Purchase order related to previous supply to Institutes/Hospitals, Catalogues, Data Sheet, PAN number, GST Registration copy, Bank details, Technical Compliance Statement, Proprietary certificate from the manufacturer (if applicable), Pre requirements required for using chemicals, Non – blacklisting certification that the firm has not been blacklisted in the past by any Government / Private institution and certification for No Vigilance/CBI case pending against the firm/supplier by making an affidavit on non – judicial stamp paper of `10/-, Declaration, etc.).
