1. The tender is QCBS format, where weightage for technical bid will be 60% and 40% will for price bid. Formula for the QCBS format:

**Financial Bid Evaluation.**

a) The bidder with lowest qualifying financial bid (L1) will be awarded 100% score. Financial Scores for other than L1 bidders will be evaluated using the following formula

b) Financial Score of a Bidder

$$(Fn) = \{(Commercial Bid of L1/Commercial Bid of the Bidder) \times 100\}$$

(Adjusted to two decimal places)

c) Errors & Rectification: If there is any discrepancy between words and figures in the financial bid, the amount in words will prevail.



**Combined and Final Evaluation for Selection of Service Provider**

- a. The technical and financial scores secured by each bidder will be added using weightage of < 60% > and < 40% > respectively to compute a Composite Bid Score.
  - b. The bidder securing the highest Composite Bid Score will be adjudicated as the most responsive
2. Bidder for award of the Project. The overall score will be calculated as follows:-
- $B_n = 0.60 * T_n + 0.40 * F_n$**
- Where
- B<sub>n</sub>**= overall score of bidder
- T<sub>n</sub>**= Technical score of the bidder expressed in percentage
- F<sub>n</sub>**= Normalized financial score of the bidder, In the event the bid Composite bid scores are tied, the bidder securing the highest technical score will be adjudicated as the Best Value Bidder for award of the Project.
3. **The Financial Proposed for selection of firm is in eprocurement portal is in the form of Amount (Rs), this will be treated has percentage (%)**
- Example: Suppose the tenderer quote in the financial bid has
- a. Rs 2.0, this will be treated has 2% Or
  - b. Rs 9.5, this will be treated has 9.5%.
4. The Director, NIMHANS reserves the right to reject any/all tenders at any stage without any reason whatsoever and without being liable in any manner towards any bidder. Further, the Director, NIMHANS also reserves the right to either annul or cancel the bidding process at any stage without assigning any reason whatsoever and being liable in any manner towards any bidder or prospective bidder.
