

<u> Specifications for VEIN FINDER – 01 No.</u>

Justification: chronically ill patients and children have frequent venous access problems. To avoid multiple needle pricks, vein finder can be used to achieve successful venous access.

1. Description of function

[a] The vein finder should be able to define the subcutaneous veins for the purpose of venipuncture and venous cannulation across all age groups.

2. Operational requirements

[a] The vein finder should work on the principle of class 2 red laser light and must comply with laser safety norms

[b] Should be battery operated, portable, hand held (including mounting facility)

[c] Depth penetration must be at least 5-6mm

[d] Demonstration of equipment is a must.

3. Technical specifications

[a] Device

[i] Hand held device weighing not more than 400-500 grams

[ii] The device should have the facility to be mounted on to the bed/table for hands free operation. A dedicated mounting stand preferable.

[iii]Should operate on rechargeable battery. Battery charger to be provided. On full charge, the device must work for at least 2 hours.

[b] Display

[i] Vein should stand in the light background.

[ii] Inverse display is a must (veins appearing lighter)

[iii] The image should be projected on to the patient skin to facilitate vascular access

[iv] Adjustable display size

[v] The battery level indicator must appear on the display

[c] Image

[i] Brightness: minimum 10 lumens

[ii] Resolution: minimum 500x600 pixels

[iii] Adjustable brightness level

[iv] Minimum 2 colour display

4. Others:

[a] The power cord supplied for battery charger must fit to Indian plug system

[b] Each vein view finder must come with one spare rechargeable battery, one mount clamp for hands-free operation and one mounting stand for easy portability

[c] FDA/CE approved product

[d] The company should have the necessary technical, production and after sales services.

[e] The company should be willing to provide stand by equipment or replace the faulty equipment if the repair/down time extends beyond 72 hours from the time of reporting.

[f] Preventive maintenance as per the manufacturer's recommendation shall be done at free of cost in warranty period. All parts required for the preventive maintenance shall be replaced at free of cost.

[g] The company should have a minimum of 3 years of experience in the sales and services of the equipment within India.

[h] Warranty – 3 years

Terms & Conditions

1. The tender is of **Two bid system, i.e. Technical Bid** (Technical details, delivery period and other relevant documents **except Price bid**) and **Price Bid** (Price quotation) valid for **four months** from the due date should be submitted separately in different envelopes superscribing Technical Bid & Price Bid for the supply of **Vein Finder – 01 No.** for tender No. **STR-D3/EQPT/** /**VF/NA/2020-21.** The tender bids received after the due date and time will be rejected. **NIMHANS, Bengaluru will not take any responsibility for delay, loss or non-receipt of the tender documents sent by post or under any other circumstances.**

2. Sealed tender bids (both technical & price) should be submitted only by either manufacturer of the articles or the authorized local supplier of the manufacturer. Copy of authorization letter has to be enclosed.

3. Validity of both the tender bids should be for 120 days from the due date.

4. Vein Finder – 01 No. should be covered with 3 years warranty for normal or regular wear & tear from the date of complete installation (Ready to use in all respects).

5. Quantity of items may be increased / decreased as per requirement.

6. Price bid should be in INR for NIMHANS door delivery price and total cost with detailed breakup of cost towards Item wise price, taxes, any surcharges (such as transportation, installation, customs duty, etc.), warranty period, delivery period, grand total, contact person details (such as Mobile No., E-mail, local supplier address) should be clearly mentioned.

7. Technical bid must be submitted along with relevant documents counter signed along with seal by the bidder (such as Authorization certificates, Purchase order related to previous supply to Institutes/Hospitals, Catalogues, Data Sheet, PAN number, GST Registration copy, Bank details, Technical Compliance Statement, Proprietary certificate from the manufacturer (if applicable), Pre requirements required for using chemicals, Non – blacklisting certification that the firm has not been blacklisted in the past by any Government / Private institution and certification for No Vigilance/CBI case pending against the firm/supplier by making an affidavit on non – judicial stamp paper of ₹10/-, Declaration, etc.) If not submitted, Technical bid will be treated as incomplete and may be rejected.

8. If the purchase of article is approved by the Institute, the article should be supplied/installed within the delivery period quoted else penalty will be levied as per institute rules.

9. The cost of the "Vein Finder" will be freezed for 1 Year from the date of purchase order; however Institute reserves the right to procure/reject the purchase of "Vein Finder" with the successful tenderer on repeat order basis within 1 year from the date of purchase order.
