Tender form can be had from the Office of the Assistant Administrative Officer (PR) on payment of ₹ 500/- at the cash counter, NIMHANS.
- 2 Sealed Tenders will be opened on 05.02-2021 at 3.30 PM in the presence of Tenderers.
- 3 No tender will be accepted unless accompanied by D.D (in favour of Director, NIMHANS) for Rs- 5,000/- (Rs. Five thousand only) as Earnest money deposit (EMD)
- 4 The EMD amount will be refunded to the unsuccessful tenderers after finalization of the tender procedure.

22 The tenderer shall clear all the coconuts trees falling fronds, immature nuts and leaves

from the trees as and when occur.

23 Tenderer should not harvest the produce during the General Holidays of the Institute.

24 The tenderer should not harvest the immature Fruits/Nuts during and towards end of the

tender period.

25 Tenderer should not indulge in illegal activities and also not to obstruct the Institute garden

working force from their routine work.

26 Tenderer shall not harvest the produce the day after the tender period is ended.

27 For any reasons, the tender period will not be extended as notified.

28 While harvesting the Fruits/Nuts every care should be taken by the tenderer not to cause

any damage to trees and Institute infrastructures.
