Instructions to provisionally selected PG candidates under second round of seat allotment

1. Provisional Selected candidates list is announced in the ratio of 1:2 against available seats based on the vacant position from 1st round of admission. The list displayed is in the ratio of 1:2 i.e., for one available seat 2 candidates are being called of which there will be one selecting the seat and the other is again waitlisted. This selection will be based on merit list and willingness to join. This is being done to facilitate early admission into the course which has already commenced on 2nd August, 2021.
2. Allocation of seats is based on point based roster being followed from AY 2021-22 and roster committee recommendations.
3. **Both selected and waitlisted candidates are permitted to furnish their willingness through link available on the website between 07.08.2021 to 11.08.2021** to join course at NIMHANS failing which candidature to join any course will not be considered at any cost. Non-submission of willingness through link (incase of selection) or not reporting on the scheduled time of admission is not a valid reason for claiming seat at a later date. **Further, as this is the second round of willingness candidates are STRICTLY NOT PERMITTED to take extension for joining the course through willingness window, if asked for extension through link the same will not be considered.** Kindly visit website for further updates.
4. **The candidates who have submitted willingness has to attend the admission procedure on 16.08.2021 @ 09.30 AM @ Exam Hall, NBRC Building, 4th Floor.**
5. Candidates are permitted to complete Admission procedure subject to verification.
6. **The candidates admitted on 16th August, 2021 are required to report to the Department on the same day. Failing to report on 16th August, 2021 will lead to allotment of seat to the waitlisted candidates.**
7. COVID norms as per guidelines of Govt. of India and Govt. of Karnataka shall be strictly applicable and adhered to. The candidates must submit RT-PCR Negative report which is not older than 72 hours as on 16th August, 2021.
8. Candidates who have given willingness have to report without fail. The institute is not responsible for inability to attend admission procedure due to various reasons including COVID 19 positive, travel restrictions etc.,
9. **Admissions to course will stop immediately after the vacant seats are filled. Waitlist candidates will be offered seat only if the vacant seats are not filled.**

The following admission formalities are required to be completed by the candidates who have given willingness:

1. Candidates have to report at venue with hardcopies of their Declaration certificate by applicant, guardian and employer, Declaration and oath/ affirmation form by the student, Medical fitness certificate (formats enclosed)
2. Safety measure towards COVID 19 pandemic situation to be strictly followed by candidates during entire session of admission procedure.
3. Verification of original documents/certificates on the day of admission.
4. Hostel allotment will be from 16.08.2021 only subject to availability.
5. Fee details is available at page no. 84 & 85 of Prospectus 2021-22
6. Tie-breaking (if applicable) will be done on the day of admission as per Page no. 80 of Prospectus.
7. The candidate shall submit all original certificates/documents as stated in prospectus page from 76 to 78 along with five sets of photocopies of certificates/documents.
8. Submit two recent Stamp-size and Passport Size Photographs.
9. **Remit Fees through SB Collect only using Debit Card / Credit Card or Net Banking and submit hardcopy of e-receipt during admission formalities**
10. Submit a self-attested Photocopy of PAN Card, Aadhaar Card and Voter ID.
11. Agreement Bond format will be shared after completion of admission formalities via email, which needs to be submitted by candidate on 25.08.2021 without fail.
12. Kindly refer to Page 82 of Prospectus 2021-22 regarding Penalty Clause.
13. **Candidates selected under External Fellowship category shall produce valid Fellowship certificate.**
14. **Candidates whose final semester results are not yet declared, have to bring the results in confidential cover from previous Institution/College.**
15. The decision of the Director of the Institute shall be final in all matters of selection of candidates for admission to the various courses and no appeal shall be entertained on this subject.
