Instructions to candidates appearing for Ph.D. Entrance Test:

1. Provisional list of candidates selected for interview will be announced by 02.00 PM on 28.12.2021 based on qualifying marks (50 marks & above in the entrance test) obtained by the candidates.

2. Candidate should obtain 50 marks and above in the written test and the final selection is on 70% weightage for

written test and 30 % for interview.

3. During the Interview the candidates are required to discuss their research interest/areas. The candidate should possess the competence for the proposed research. Further, the proposed area of research should contribute new/additional knowledge in a particular area / subject.

4. Admission to the Ph.D. course is also based on no. of eligible recognized guides available in respective

department for the AY 2021-22 (available on website)

5. The candidates are requested to go through the list of eligible Guides and their research areas as notified in Annexure-1 along-with the Prospectus and Notification available in NIMHANS Website for the respective departments. In addition, the candidates have to identify tentative guides based on their research areas and may be indicated during the interview.

 Provisionally qualified candidates in the Entrance Test are <u>only</u> permitted to attend the interview at Neurobiology Research Centre (NRC), 4th Floor, Exam Hall scheduled on the same day i.e., 28.12.2021 @ 02.00 PM.

 Candidates have to complete Admission procedure based on decision of interview committee on the same day and have to report to their respective departments on 01.01.2022.

The following admission formalities are required to be completed by the candidates.

1. Candidates who are deputed, sponsored and already pursuing other courses at NIMHANS or elsewhere have to produce original NOC issued by the Competent Authority to be eligible for admission.

2. Safety measure towards COVID 19 pandemic situation to be strictly followed by candidates during entire session of admission procedure.

3. Verification of original documents/certificates on the day of entrance test / admission.

4. Hostel allotment will be from the date of joining only subject to availability.

- 5. Fee details is available at page no. 28 & 29 of Prospectus 2021-22 session 2 and to be paid on the day of admission, in the event of selection.
- 6. The candidate shall submit all original certificates/documents as stated in prospectus page from 22 & 23 along with five sets of photocopies of certificates/documents.

7. Submit two recent Stamp-size and Passport Size Photographs.

8. Remit Fees through SB Collect only using Debit Card / Credit Card or Net Banking

9. Submit a self-attested Photocopy of PAN Card, Aadhaar Card and Voter ID.

- 10. Agreement Bond format will be shared after completion of admission formalities via email, which needs to be submitted by candidate on or before 10.01.2022 without fail.
- 11. Kindly refer to Page 26 of Prospectus 2021-22 session 2 regarding Penalty Clause.
- 12. Candidates selected under External Fellowship category shall produce valid Fellowship certificate.
- 13. Candidates whose final semester results are not yet declared, have to bring the results in confidential cover from previous Institution/College.
- 14. The decision of the Director of the Institute shall be final in all matters of selection of candidates for admission to the various courses and no appeal shall be entertained on this subject.
