1	Removing existing ‘Multi-wall polycarbonate’ sheet by removing the existing aluminium strips, stacking the multi-wall polycarbonate sheet at a designated place and then disposing it safely, providing 5mm thick solid, embossed polycarbonate sheet and fixing it to the existing purlins by providing aluminium strips of 50mm wide on the top and also at the bottom to ensure that, the polycarbonate sheet is sandwiched between the aluminium strips to prevent entry of water. The rate includes providing and removing the scaffolding wherever required. The work has to be carried out without disturbing patient care activities in the Emergency block by providing suitable horizontal barrier/sheet to prevent any injury to the staff and patients working at the ground floor level. The barrier/sheet must be fixed at the first floor level. The firms/agencies/contractor must ensure prevention entry of rain water into the ground floor area from the skylight. The work includes providing new purlins and other structural mild steel members wherever required, complete, including cost of all materials, labour charges, with all lead and lift, loading and unloading, transportation, machineries and all other incidental charges for successful completion of the work as per directions of the Engineer-in-charge of the work.(Rate to be quoted including GST)	Sqm	450.00	

**Terms and Conditions:**

1. The tender should be a valid class-III and above registered contractor in KPWD/CPWD.
2. The agency should furnish Registration Certificate of GST.
3. All the items rates quoted in the quotation include all lead, lifts, loading, unloading, transportation, labour, hire charges of machinery, cost and conveyance of all materials and all such incidental charges for successful completion of the works as per the detailed technical specification and direction of Engineer-in charge of the work.
4. No advance payment shall be paid for the successful agency.
5. If the dates mentioned happens to be Institute holiday the next working day should be considered.
6. Contractor should follow strictly the prevailing rules of labour act as per GOI. Necessary safety arrangement should be made for labours such as safety belts, helmets etc.

9. The agency should inspect the NIMHANS hospital along with concerned Engineer before quoting lowest rate since its entire premises covers under patient care activities.
